Environmental Health and Sanitation Regulation #4

A regulation of the Kenton-Hardin General Health District Board defining regulations governing the storage on premises, collection and transportation of solid wastes.

Be it resolved by the Board of Health of the Kenton-Hardin General Health District as follows:

SECTION I DEFINITIONS

- Health Commissioner means the health commissioner of the Kenton-Hardin General
 Health District or his authorized representatives.
- 1.2 <u>Board of Health</u> means the Board of Health of the Kenton-Hardin General Health District.
- 1.3 <u>Person</u> means an individual, partnership, association, syndicate, company, firm, trust, corporation, government corporation, department, bureau, agency or any entity recognized by law.
- 1.4 <u>Solid Waste</u> means such unwanted residual solid or semi-solid materials as results from industrial, commercial, agricultural and community operations, excluding earth or material
 - from construction, mining or demolition operations and slag and other substances which are not harmful or inimical to public health, and includes garbage, combustible and non-combustible material, street dirt and debris.
- 1.5 <u>Premises</u> means any land, buildings or structures upon or in which solid waste may be temporarily stored, placed or accumulated.

PREMISE MAINTENANCE

- 2.1 No person shall store, place, burn or dispose on his premises or the premises of another or permit to accumulate on his premises, any solid waste in such a manner whereby it will become a rodent or harborage or breeding place to create a health menace, unsanitary condition or nuisance.
- 2.2 No person shall dispose of solid waste on his property other than approved sanitary landfill, incinerator or other method approved by the Health Commissioner.

SECTION III VEHICLE FEE

- 3.1 It shall be unlawful for any person to engage in the business of collection or transportation
 - of solid waste within the Kenton-Hardin General Health District unless he holds a valid license issued to him by the Health Commissioner.
- 3.2 The annual license fee shall be \$25.00 per vehicle engaged in the collection of solid waste.
- 3.3 Each license issued must be renewed on or before January first of each year hereafter.

SECTION IV SOLID WASTE COLLECTION

4.1 All vehicles used for the collection and transportation of solid waste, unless all the solid waste is kept in watertight, covered containers, shall have closed bodies or covered with a tarpaulin, securely fastened so no debris may escape. All vehicles shall be leakproof, of easily cleanable construction, shall be cleaned at sufficient frequency to prevent odor,

nuisance or insect breeding, and shall be maintained in good repair.

SECTION V PENALTIES

5.1 Any person who violates any provision of this regulation is subject to the penalties by Section 4709.99 of the Ohio Revised Code.

SECTION VI EFFECT OF PARTIAL INVALIDITY

6.1 Should any part of this regulation be declared unconstitutional for any reason, the remainder of this regulation shall not be affected thereby.

SECTION VII EFFECTIVE DATE

7.1 This regulation shall be effective on and after the first day of January, 1990.
